Uptick in overdose deaths driven by opioids

Drug overdose deaths increased for the 11th consecutive year in 2010, according to a <u>new analysis</u> published in the Journal of the American Medical Association. Leading the list of drugs responsible for these fatalities are prescription medications, especially opioid analysis.

The analysis, conducted by the Centers for Disease Control and Prevention (CDC), found that 38,329 people died from a drug overdose in 2010—up from 37,004 deaths in 2009 and 16,849 deaths in 1999. Nearly 60 percent of the overdose deaths in 2010 involved pharmaceutical drugs, with opioids associated with roughly 75 percent of these deaths.

Webster, MD, president-elect of the American Academy of Pain Medicine, shares eight tested principles for managing pain while avoiding misuse of prescription opioids.

The <u>second webinar</u> features an overview of the epidemiology of prescription drug overdoses and deaths, presented by speakers from the CDC. The webinar also explains the factors associated with an increased risk of unintentional overdoses from opioids as well as public policy and clinical practice strategies to promote responsible opioid prescribing.

These AMA-sponsored webinars are the first in a 12-part <u>series</u> on topics related to responsible opioid prescribing. They are part of a larger collaborative project called the Prescribers' Clinical Support System for Opioid Therapies, which offers additional prescribing resources <u>online</u>.
