# **Speaker Biographies**

### Bill Barcellona, California Association of Physician Groups

Bill Barcellona serves as the Vice President for Government Affairs for the California Association of Physician Groups, and is the former Deputy Director for Plan-Provider Relations for the DMHC. Bill holds an MHA from the USC and serves as an adjunct professor in the health administration program. He has practiced law for 24 years. Bill currently serves on the Health and Human Services Privacy and Security Advisory Board to Secretary Kim Belshe' and is also an appointed member of the California State Bar Association Insurance Law Committee.

### Serena Clayton, California School Health Centers Association

Serena Clayton, Ph.D., has been the Executive Director of the California School Health Centers Association (CSHC) since March 2003. During this time the organization as successfully passed two bills that create a foundation for a school health center program in the state of California and has worked actively on health care reform at the national level. Dr. Clayton guided the organization through a period of Board restructuring, growth of the organization's annual budget from \$100,000 to almost \$1 million employing ten staff members, and development of a 13 member youth board. Prior to heading CSHC, Dr. Clayton directed the California Adolescent Health Collaborative and was the principal author of California's first adolescent health strategic plan, Investing in Adolescent Health: A Social Imperative for California's Future. Through her work at the Public Health Institute, UCSF's National Adolescent Health Information Center, and SRI International, Dr. Clayton has extensive experience in evaluation of programs in the areas of teen pregnancy prevention, sex education, school-based services, early childhood, and perinatal home visiting. Dr. Clayton was one of the lead consultants on the needs assessment for California's Blueprint for Coordinated School Health. She formerly served as the Director of Assessment and Planning in Philadelphia's Office of Maternal and Child Health. Dr. Clayton received her Ph.D. in Community Health Sciences and her M.A. in Education from UCLA.

# Kenneth B. Cohen, San Joaquin County Health Care Services

Kenneth Cohen is the Director of San Joaquin County Health Care Services Agency. He is responsible for administration of four major divisions of Health Care Services: San Joaquin General Hospital (SJGH), Mental Health Services, Public Health Services, and Office of Substance Abuse. SJGH offers outpatient clinics and in-hospital care. Outpatient, education, rehabilitation and consultant services are provided to mental health patients. Office of Substance Abuse offers a wide array of prevention and treatment services and administers Proposition 36. Public Health Services include maternal, prenatal care, child health, and nursing.

### Jonah Frohlich, The California Health and Human Service Agency

Jonah Frohlich is the deputy secretary for health information technology for the California Health and Human Services Agency. Previously, Mr. Frohlich was a senior program officer in the Foundation's Better Chronic Disease Care program, which focuses on improving the quality of care for Californians with chronic diseases. Within that program, his area of expertise is the use of health information technology to improve care. Mr. Frohlich's earlier Foundation work involved the management and development of national and statewide data exchange standards to support electronic health information exchange, as well as the development of chronic disease management registries. He also worked as a health care consultant for the Foundation, as the manager of reporting and analysis for Brown & Toland Medical Group in San Francisco, and as the director of product management for WebOS, Inc. in Baltimore. Mr. Frohlich has a degree in economics from McGill University in Montreal, Canada, and a master's degree in public health from the University of California, Berkeley.
