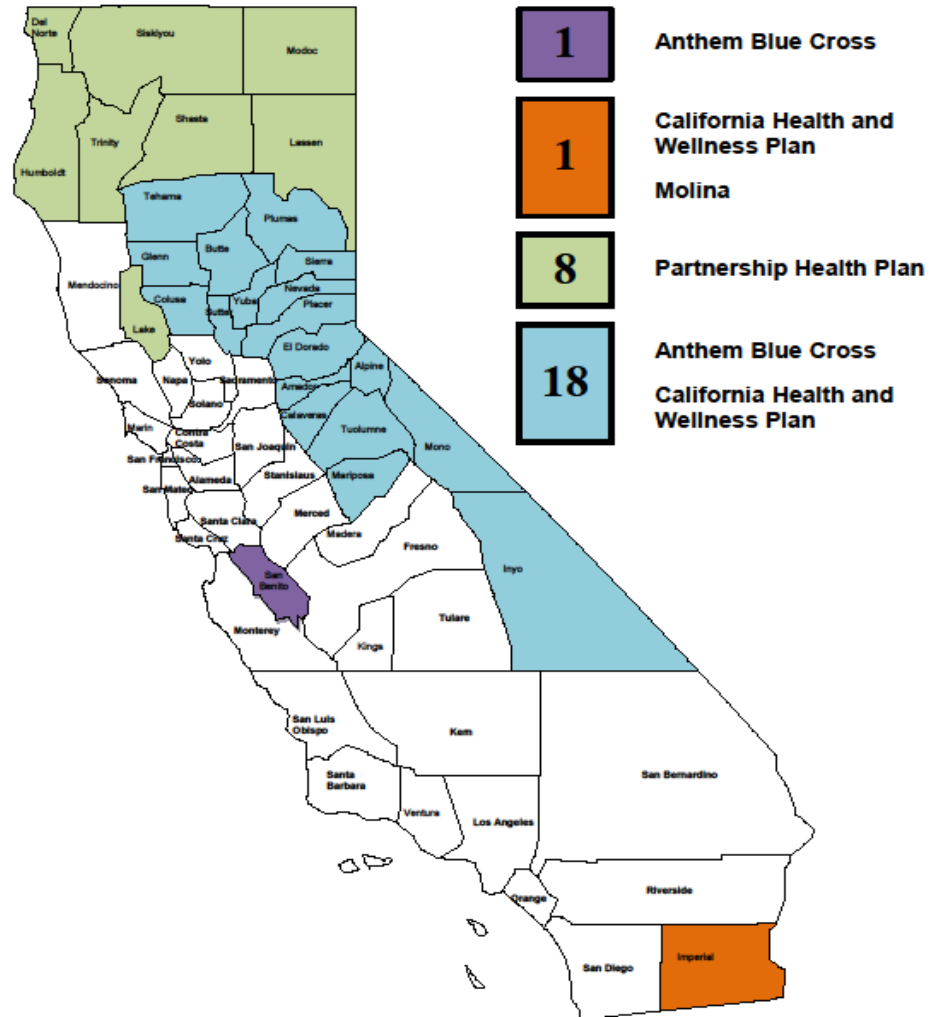

Medi-Cal Managed Care Expansion: Rural Counties

- **When:** September 1, 2013*
- **Where:** 28 Rural Counties
- **What:** Medi-Cal Managed Care
 - SPDs mandatorily enrolled in Managed Care
 - Excluded: Duals, SOC, Nursing Facility Residents, Other Insurance, Foster Children
 - Except: Mandatory enrollment of Duals in COHS counties

Rural Expansion: Implementation & Implications

75,092 Duals and SPDs Mandatorily Enrolled

 - Mandatory Medi-Cal for all SPDs including duals
 - LTSS integration
 - Cal MediConnect

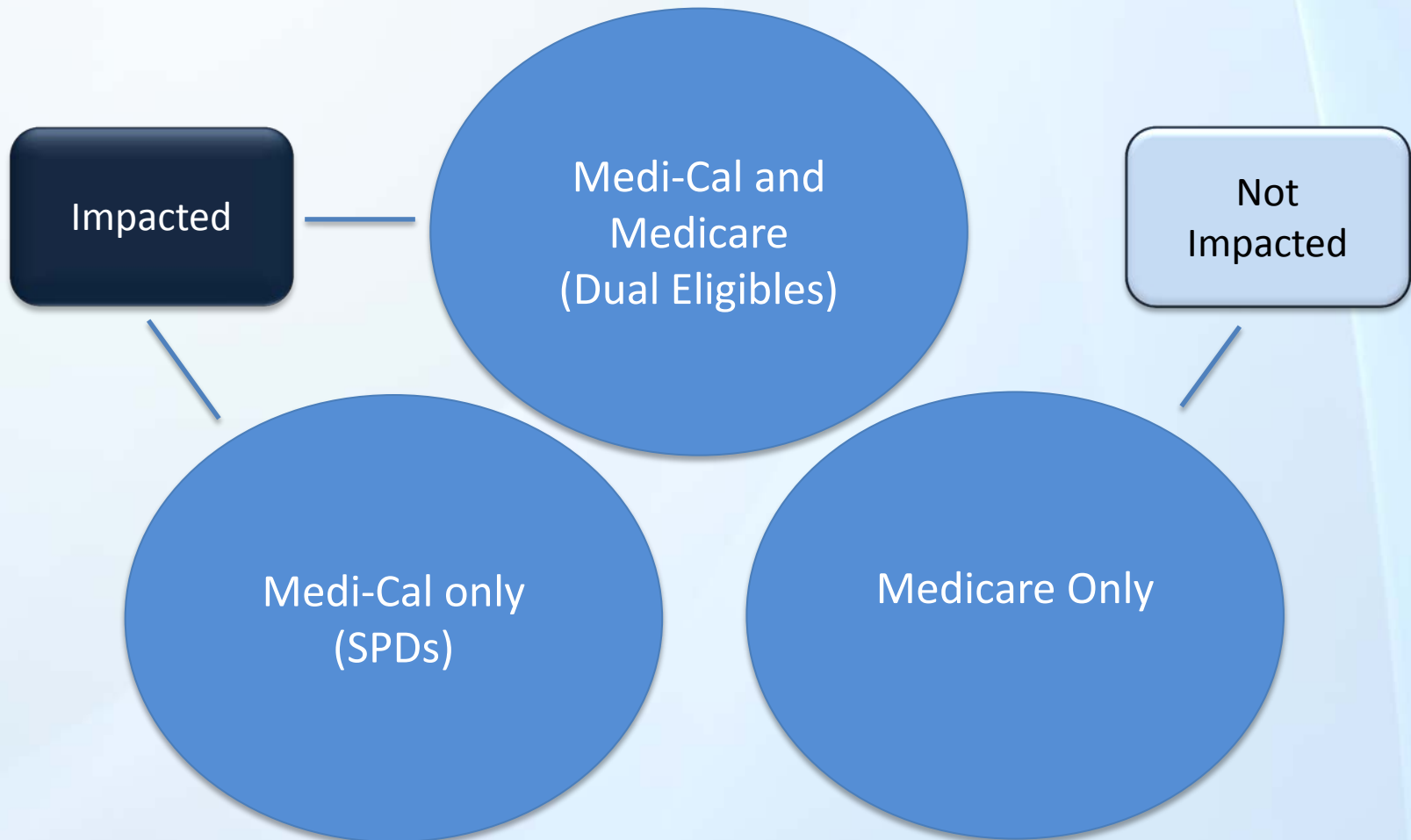

Coordinated Care Initiative: What

CCI Change	Description
Mandatory Medi-Cal Managed Care	Duals and previously excluded SPDs must in enroll in Medi-Cal Managed Care
LTSS Integration	LTSS added to Medi-Cal Managed Care plan benefit package
Medicare Integration (Cal MediConnect)	For duals, passive enrollment of Medicare benefits into same MC plan
