Notes:

Large Group includes Federal Employees Health Benefit Plan and Tri-Care enrollment, reported as distinct categories under CDI.

Commercial Enrollment = Individual + Small Group + Large Group.

Medicare is managed care enrollment (Medicare Risk + Medicare Cost); it excludes Medicare Part D coverage and Medicare Supplement.

Medi-Cal and Other Public = Medi-Cal managed care + Healthy Families + Aid to Infants & Mothers (AIM).

Other Insured = Student + Mini-Med + Other Sources of Enrollment. Student and Mini-Med categories exist only under CDI; Other Sources is a DMHC category.

From Other Plans is subcontracted enrollment (often Medi-Cal), a DMHC-only category.

Total Insured = Commercial & Public + Other Total.

ASO is Administrative Services Only, which are provided to self-insured employers.

Adjustments made in 2012 and 2013 to include deductible HMO products in individual and group categories; reporting changes make this adjustment unnecessary beginning with 2014. Sub-contracting of Medi-Cal managed care enrollees likely results in double counting of some one million enrollees; note that Department of Health Care Services, December Medi-Cal Managed Care Enrollment Report for Dec 2014, reports 8.88 million enrollees.
