Bills Referred to the Human Services Committee

SENATE BILLS

- SB 1 (Cedillo) Immigration services
Establishes an Office of Immigrant Affairs within the Department of Community Services and Development and gives responsibilities to the director of that office.
Bill amended to another subject
- SB 42 (Torlakson) CalWORKs
This bill would count participation in an educational program as a “work activity” in CalWORKs when the person has submitted a timely application to a qualifying educational program and is awaiting acceptance to that program. Held in Assembly
- SB 58 (Hollingsworth) CalWORKs
Imposes new requirements on families receiving a child-only CalWORKs grant after the head of the assistance unit has reached the end of his or her 60-month limit on assistance.
Withdrawn
- SB 104 (Machado) Crisis Nurseries
Removes the sunset for a community care license for “crisis nurseries” -- short term, 24-hour non-medical residential care and supervision for children under six years of age, who are either voluntarily placed for temporary care by a parent or guardian, for up to 30 days or who are temporarily placed by a county child welfare service agency for no more than 14 days. Chapter 288, Statutes of 2007
- SB 126 (Harman) Child Abuse and Neglect
Requires the State Board of Education to adopt, on or before March 1, 2008, content standards on child abuse and neglect in the curriculum area of health education.
Withdrawn
- SB 179 (Ashburn) CalWORKs
Replaces the current quarterly income reporting system for recipients of CalWORKs and food stamps with a semi-annual reporting system that would also include reporting changes in income that exceed a stated threshold. Failed passage
- SB 197 (Ducheny) Child care
Allows foster children who are enrolled in subsidized child care programs and who change foster homes to remain in child care for up to 30 days while the eligibility for child care of their new parents is being verified. Failed passage
- SB 269 (McClintock) Public assistance
Requires an investigator from the district attorney’s office to conduct an interview with and to walk through the residence of each applicant for CalWORKs. Failed passage

- SB 330 (Human Services Committee) Community services
Brings up-to-date code sections dealing with the Department Community Services and
Development. Chapter 46, Statutes of 2007
- SB 434 (Romero) Long-term care
Establishes a commission and charges it with designing and implementing a
comprehensive long-term-care program to provide services promoting independent living
for seniors. Failed passage
- SB 468 (Padilla) Child abuse and neglect
Establishes in up to ten counties a pilot public-education program to prevent incidents of
shaken baby syndrome. Failed passage
- SB 489 (Steinberg) Continuing care contracts
Imposes requirements on continuing care retirement communities in the event of their
closure. Vetoed
- SB 491 (Alquist) Aging
Changes the composition of the State Alzheimer's Disease and Related Disorders
Advisory Committee and requires the committee to make various recommendations.
Chapter 339, Statutes of 2007
- SB 648 (Calderon) Juveniles
Requires the Department of Health Care Services to suspend rather than terminate Medi-
Cal benefits of an incarcerated minor. Withdrawn
- SB 680 (Ridley-Thomas) Child care
Provides funds to child care resource and referral programs to facilitate inclusion of
children with disabilities into child care programs. Withdrawn
- SB 688 (Cox) Children and Families Commission
Limits the discretion of the state Children and Families Commission to expend funds
without a statutory authorization by the Legislature. Withdrawn
- SB 693 (Ashburn) Child care
Specifies that payment to a child care provider shall not commence until the State
Department of Social Services confirms that the child care provider is a registered child
care trustline provider or is exempted from trustline registration. Failed passage
- SB 703 (Ducheny) Foster care
Conforms provisions of state law to federal law as it relates to intercountry adoptions,
home studies for foster care and adoptive placements, criminal background checks for
foster and adoptive parents and Indian Child Welfare Services.
Chapter 583, Statutes of 2007

SB 914 (Hollingsworth) Community care facilities
Allows local jurisdictions to require community care facilities housing an adult or
juvenile sex offender to obtain a business license. Failed passage

SB 945 (Padilla) IHSS
Allows in-home supportive services (IHSS) recipients to authorize a family member or
their individual provider to receive a copy of a notice of action concerning IHSS services
to be provided and to file a hearing request on behalf of a recipient. Vetoed

SB 977 (Correa) Aging
Provides for independent review of data related to senior centers in California. Vetoed

SB 1094 (Cedillo) Immigrant affairs
Establishes an Office of Immigrant Affairs within the Department of Community
Services and Development and gives responsibilities to the director of that office.
Failed passage

SB 1136 (Alquist) Social services
Creates a private right of action for a person who has been charged unreasonable fees for
assistance in procuring public social services. Chapter 479, Statutes of 2008

SB 1148 (Cedillo) Foster children
Requires courts to retain jurisdiction over dependent children who reach the age of
majority without verification that the youth has housing, health insurance, and
employment or other financial support. Failed passage

SB 1160 (Alquist) Social services
Exempts non-needy caregivers from certain re-certification requirements when moving
from one county to another with their foster child; extends the sunset date for the Youth
Pilot Project. Chapter 484, Statutes of 2008

SB 1175 (Steinberg) Developmental services
Allows the State Department of Developmental Services to approve proposals from any
regional center for leasing housing; and, adds “residential facility for persons with
developmental disabilities” to the definition of facilities that can be financed by the
California Health Facilities Financing Authority. Chapter 617, Statutes of 2008

SB 1183 (Wiggins) Developmental disabilities
Provides that the Department of Developmental Services operate an outpatient clinic at
Sonoma Developmental Center to provide medical, dental, and other health-related
services for regional center clients. Failed passage

SB 1317 (Steinberg) Developmental services
Establishes a new category of employment programs, the “career opportunity program,”
for persons with developmental disabilities. Failed passage

SB 1341 (Padilla) CalWORKs
Allows persons applying for or receiving CalWORKs benefits to have savings to secure permanent rental housing or to make rent payments to overcome an episode of homelessness. Chapter 485, Statutes of 2008

SB 1380 (Steinberg) Foster care
Expands eligibility for the intensive treatment foster care programs. Chapter 486, Statutes of 2008

SB 1475 (Torlakson) Autism
Directs the Department of Developmental Services to use an advisory body to identify best practices in providing a smooth transition for young autistic children and their families when the children change programs provided through regional centers to programs operated by the public schools. Vetoed

SB 1599 (Wiggins) IHSS
Directs the Department of Social Services to establish a process to allow qualifying individuals to purchase in-home supportive services. Failed passage

SB 1774 (Corbett) Developmental disabilities
Changes the composition of the State Council on Developmental Disabilities, adding a third representative from university centers for excellence, adding an additional person with developmental disabilities, and allowing heads of state departments to designate their representative. Chapter 419, Statutes of 2008

ASSEMBLY BILLS

AB 98 (Niello) CalWORKs
This bill provides that the state contribute half of the wage subsidy for subsidized employment programs operated by counties for California Work Opportunity and Responsibility for Kids participants. Chapter 589, Statutes of 2007

AB 149 (Bass) Foster children
Requires the State Department of Social Services (DSS) to contract for technology to assist counties in searching for relatives to serve as caretakers for foster children and establishes a pilot project to use technology which would assist counties in identifying relatives and to assist family caregivers in navigating the services available to children in out-of-home care. Vetoed

AB 167 (Bass) CalWORKs
Repeals the limit on the value of assets which can be owned by an applicant or recipient of California Work Opportunity and Responsibility for Kids (CalWORKs) program.
Failed passage

AB 182 (Ma) IHSS
Requires the State Department of Social Services (DSS) to develop standards for training provided to in-home supportive services (IHSS) providers and recipients. Vetoed

AB 184 (Dymally) Foster youth
Requires that Independent Living Program services be provided to former foster youth who are: 1) Placed with a non-related legal guardian if the child is receiving permanent placement services; 2) Placed as wards with a non-related legal guardian who receives AFDC-FC benefits and case management services; or 3) Adopted at 14 years of age or older.
Failed passage

AB 238 (Beall) IHSS
Adds reading assistance for financial and other documents to the required services available to blind or visually impaired recipients of in-home supportive services (IHSS).
Vetoed

AB 273 (Jones) Foster children
Requires that foster children receive Child Health and Disability Prevention (CHDP) program health assessments and oral health services. Requires the county welfare department, at a hearing to terminate jurisdiction over a dependent child, to submit a report verifying that assistance in understanding the child's health care needs, as well as locating health care providers who will be able to meet those needs has been provided to the child. Requires the Department of Health Care Services, to the extent federal financial participation is available, to extend Medi-Cal benefits to "independent foster care adolescents," as defined, while in foster care or guardianship, until the child reaches the age of 21 years.
Failed passage

AB 277 (Soto) Foster care
This bill: 1) Deletes the prohibition that the inability, in and of itself, of a prospective foster parent to meet a child's varying needs does not preclude a prospective foster parent from obtaining a foster family home license; 2) Increases from 8 to 12 the annual number of post-placement training hours that a foster parent must complete to retain eligibility for foster child placements; 3) Specifies that the post placement annual training include courses that cover: a) The dependency court process; b) The participation of foster children and foster parents in the court process; c) Permanency options for foster children; and d) Services and supports available to foster parents that provide permanent placements for foster children; 4) Specifies that each community college district with a foster care education program make available orientation and training programs for relatives and non-relative extended family members

cover the dependency court process and participation by foster children and foster parents in the court process; 5) Requires the county child welfare agency to provide to a foster caregiver or relative or non-relative extended family member caregiver a plan outlining the child's needs and services within 30 days of the child's placement; 6) Requires the State Department of Social Services (DSS) to develop, in consultation with counties and caregivers, a statewide standardized format for the needs and services plan which must include: a) Any information relating to the child's needs that is necessary for the caregiver to provide effective care to the child; b) Any services the county will provide to meet the needs of the child; and, c) A copy or summary of any court order pertaining to the needs of the child; 7) Requires that the statewide needs and services plan be used by all county welfare agencies by not later than July 1, 2008; and 8) Requires that a needs and services plan developed for a child be updated annually or as often as necessary to reflect any changes in the plan. Vetoed

AB 304 (Huff) Community care facilities
Requires licensed community care facilities and residential care facilities for the elderly to provide a copy of their disaster and mass casualty plan to fire, police, civil defense and disaster authorities in the area upon request. Chapter 18, Statutes of 2007

AB 314 (Soto) CalWORKs
Permits structured and monitored study time hours related to vocational training and education to count as a core welfare-to-work activity in the California Work Opportunity and Responsibility to Kids (CalWORKs) program. Vetoed

AB 317 (Berg) Community care facilities
Requires the California Department of Aging to provide technical assistance and training for Alzheimer's Day Care Resource Centers. Bill amended to different subject.

AB 335 (De Leon) Homeless assistance
Allows sworn statements by victims of domestic violence to be sufficient to establish eligibility for CalWORKs homeless assistance. Chapter 726, Statutes of 2007

AB 340 (Hancock) Child welfare services
Creates the unified resource family approval pilot project. Chapter 464, Statutes of 2007

AB 433 (Beall) Food stamp program
Requires the Department of Social Services (DSS) to propose a new name for the California Food Stamp Program (FSP), and to establish a federal option known as categorical eligibility for food stamp benefits for specified households who are eligible for services funded by the Temporary Assistance for Needy Families (TANF) block grant. Chapter 625, Statutes of 2008

AB 508 (Swanson) Food stamp program
Repeals the lifetime disqualification from food stamps for persons convicted of specified felonies involving controlled substances. Vetoed

AB 690 (Jones) Social services
Declares a legislative goal of halving child poverty by January 1, 2018, and eliminating it by January 1, 2028. Failed passage

AB 749 (Wolk) Residential care facilities for the elderly
Prescribes an emergency plan for residential care facilities for the elderly.
Chapter 477, Statutes of 2008

AB 759 (Karnette) Residential care facilities for the elderly
Requires an annual fire inspection of residential care facilities for the elderly.

Vetoed

AB 836 (Bass) IHSS
Requires the State Controller to inform all providers of in-home supportive services (IHSS) that they may qualify for the federal Earned Income Tax Credit.
Chapter 397, Statutes of 2007

AB 921 (Krekorian) Social services
Permits hearing and rehearing requests beyond the specified time periods when there is a lack of notice of the decision or if good cause otherwise exists.
Chapter 502, Statutes of 2007

AB 949 (Krekorian) Residential care facilities for the elderly
Establishes procedures and duties for a residential care facility for the elderly (RCFE) prior to transferring a resident to another facility or living arrangement as a result of forfeiture of a license or change in the use of the facility.
Chapter 686, Statutes of 2007

AB 959 (Soto) Rehabilitation services
Requires the Department of Rehabilitation (DOR) to serve as a state loan guarantee agency for the Blind Vendor Revolving Loan Fund.
Chapter 687, Statutes of 2007

AB 978 (Benoit) Community care facilities
Strengthens the enforcement methods for violations of serious health and safety violations for vulnerable persons who utilize Community Care Facilities or Child Day Care Facilities.
Chapter 291, Statutes of 2008

AB 979 (Price) IHSS
Requires the State Department of Social Services (DSS) to seek federal funding for all aspects of the in-home supportive services (IHSS) program, including training for providers of services. Vetoed

- AB 1022 (Saldana) Continuing care retirement communities
Allows licensed continuing care retirement communities to contract with and provide services to elderly persons in their own residences, and exempts the residences from licensing provisions applicable to residential care facilities. Vetoed
- AB 1060 (Laird) CalWORKs
Requires semi-annual redeterminations of eligibility and benefit amounts for California Work Opportunity and Responsibility for Kids (CalWORKs) program participants and for food stamp recipients. Chapter 427, Statutes of 2008
- AB 1078 (Lieber) CalWORKs
Requires the State Department of Social Services (DSS) to develop guidelines to maximize the ability of CalWORKs participants in welfare-to-work activities to qualify for the federal earned income tax credit. Chapter 622, Statutes of 2007
- AB 1184 (Lieber) Developmental services
Requires the Department of Developmental Services (DDS) to establish a task force to monitor community placements of former residents of Agnews Developmental Center (Agnews). Vetoed
- AB 1192 (Evans) Developmental services
Requires providers to report evidence of consumer abuse to a designated state agency and requires that state agency to investigate that abuse and establish a registry of substantiated incidents. Vetoed
- AB 1331 (Evans) Foster youth
Requires counties to screen emancipating foster youth to determine their potential eligibility for federal Supplemental Security Income (SSI) disability benefits and to make applications for those who may be eligible. Chapter 465, Statutes of 2007
- AB 1382 (Leno) Food stamp program
Eliminates requirement that applicants for and recipients of food stamp benefits not receiving general assistance be fingerprint imaged as a condition of receiving benefits. Vetoed
- AB 1402 (Evans) Developmental services
Allows the recording of Individual Program Plan (IPP) meetings upon request or approval by a consumer or his or her representative and requires regional centers and vendors to provide appeals procedure information on their websites and other related posting mandates. Chapter 512, Statutes of 2007

Bills Referred to the Senate Human Services Committee, 2007-08

AB 1427 (Krekorian) Developmental services
Creates a developmental services training pilot program to improve the use of recognized training resources for direct support workers in consumer-directed developmental services. Vetoed

AB 1453 (Soto) Foster care
Directs the State Department of Social Services (DSS) to develop a plan to transform the current statewide system of group homes into a system of residentially based services and, in the interim, permits counties to enter into agreements with private nonprofit agencies to transform individual group home programs. Chapter 466, Statutes of 2007

AB 1462 (Adams) Foster care
Permits federal financial participation for the foster care of children placed in for-profit facilities, and sets limits on that federal financial participation. Chapter 65, Statutes of 2007

AB 1494 (DeSaulnier) Foster care
Expands the definition of a group home to include the Chris Adams Center operated by the County of Contra Costa. Vetoed

AB 1509 (Spitzer) Sex offenders
Changes restrictions on county placement of sex offender parolees and modifies laws related to release of parolees and to persons conditionally released in the sexually violent predator (SVP) treatment program by placing additional restrictions on placement. Chapter 573, Statutes of 2007

AB 1512 (Torrico) Foster care
Requires expedited disenrollment of a foster child from a county organized health system, when that child has received out-of-county placement, to allow the child to receive health care services in the county where the child has been placed. Chapter 467, Statutes of 2007

AB 1526 (Lieber) Continuing care retirement communities
Exempts from community care licensing certain low-income housing occupied by elderly or disabled persons; prohibits the transfer of persons in Continuing Care Retirement Communities unless specific conditions are met. Amended by author for another purpose

AB 1674 (Jones) IHSS
Authorizes five county pilot projects to offer recipients of In-home Supportive Services (IHSS) a choice of having services provided by a contracting agency or a public authority. Chapter 319, Statutes of 2008

AB 1825 (Beall) Developmental services
Establishes a process for resolving disputes between regional centers and publicly funded generic agencies, such as local education agencies. Vetoed

Bills Referred to the Senate Human Services Committee, 2007-08

- AB 1996 (Swanson) Food stamp program
Extends eligibility for food stamp benefits to convicted drug felons who distributed controlled substances. Vetoed
- AB 2038 (Lieber) Developmental services/elder abuse
Clarifies state law as it pertains to elder abuse and abuse of persons with disabilities. Failed passage
- AB 2070 (Bass) Foster care
Increases the time reunification services may be available to parents whose children are dependents of the court in consideration of barriers to service faced by parents who are incarcerated, institutionalized, or in residential substance abuse treatment. Chapter 482, Statutes of 2008
- AB 2096 (Bass) Foster care
Allows foster group home providers to use a prudent parent standard when deciding to give permission to a child in foster care to participate in extracurricular, enrichment or social activities. Chapter 483, Statutes of 2008
- AB 2117 (Evans) Foster care
Creates new safeguards before and after juvenile court judicial officers authorize the administration of psychotropic medications to foster youth. Failed passage
- AB 2160 (Carter) Aging and disabilities
Adds a definition of “disability” to the Mello-Granlund Older Californians Act. Vetoed
- AB 2252 (De Saulnier) Youth services
Establishes a state advisory commission on youth, prescribing its membership and duties. Vetoed
- AB 2263 (Caballero) IHSS
Provides for the replacement within a specified time period of lost or stolen warrants issued to in-home supportive services (IHSS) providers. Failed passage
- AB 2310 (Maze) Foster care
Requires the county welfare department to provide additional information and documents to a person in the foster care system who has reached the age of majority before the juvenile court terminates jurisdiction over that individual. Chapter 131, Statutes of 2008
- AB 2341 (Maze) Foster care
Specifies time periods during which reunification services are provided to children who are dependents of the juvenile court and their parents or guardians. Chapter 457, Statutes of 2008

AB 2368 (Fuentes) CalWORKs
Excludes the value of a licensed motor vehicle from consideration when determining eligibility for California's Work Opportunity and Responsibility to Kids program (CalWORKs). Failed passage

AB 2370 (Bass) Residential care facilities for the elderly
Requires residential care facilities for the elderly (RCFE's) to post information annually

regarding the facility's recent history of rate increases and also to disclose the rate increase information to new residents and, upon request, to prospective residents.
Chapter 478, Statutes of 2008

AB 2399 (Portantino) Developmental disabilities
Requires that services available for emancipated foster youth through the independent living program also be available for former dependents of the juvenile court who have been placed with non-related legal guardians. Failed passage

AB 2424 (Beall) Developmental disabilities
Establishes an employment first policy and makes modifications to the regional center individual program plan process to enhance opportunities for integrated work and other integrated activities for people with developmental disabilities Failed passage

AB 2651 (Aghazarian) Dependent children
Conforms state child welfare laws to federal law to ensure the continuation of federal compliance and funding. Chapter 701, Statutes of 2008

AB 2736 (Cook) Indian children, tribal adoptions
Requires the Judicial Council to study tribal adoptions, requires a special social-work report to the court in the case of adoption of an Indian child, and extends eligibility for adoption assistance payments for some Indian children. Failed passage

AB 2844 (Laird) Social services
Requires semi-annual redeterminations of eligibility and benefit amounts for the California Work Opportunity and Responsibility to Kids (CalWORKs) and food stamp programs based upon semi-annual reports of income and circumstances of recipient households. Vetoed

AB 2947 (Eng) Elder abuse
Prohibits a residential care facility for the elderly (RCFE) from requiring, as a condition of admission, that prospective residents waive various legal rights and agree to binding arbitration, including arbitration of violations of the Elder Abuse and Dependent Adult Civil Protection Act. Vetoed

AB 3015 (Brownley) Foster care
Requires several training programs to include basic instruction on the safety of foster youth at school. Chapter 557, Statutes of 2008

AJR 4 (Beall) CalWORKs
Calls upon Congress to repeal or amend provisions of law affecting welfare-to-work and child support practices, in connection with the California Work Opportunity and Responsibility to Kids (CalWORKS) program. Resolution Chapter 123

AJR 11 (Swanson) IHSS
Encourages state agencies and the federal government to ensure the renewal and protection of the In-home Supportive Services (IHSS) Plus Waiver program. Resolution Chapter 108
