#### Issue 7: Various Items – Technical Changes - Approved (Assembly 5-0) (Sentate

5-0) The following Actions/Compromises are proposed for non-conference issues:

#### **Department of Social Services**

- Issue 1: In-Home Supportive Services Overtime Exemptions Conference Compromise: Approve placeholder trailer bill language for a total of approximately \$3.1 million General Fund in 2017-18, \$2.7 million General Fund in 2018-19, \$2.8 million General Fund in 2019-20, and \$2.9 million General Fund In 2020-21 and ongoing that 1) codifies existing exemptions for live-in family care providers and extraordinary circumstances; 2) provides notices and review for IHSS consumers where a denial of a provider exemption would result in a loss of services; 3) adds a one-time notice mailing and exemption request form to providers who may be eligible for exemptions; and 4) adds an annual reassessment evaluation for potential eligibility for exemptions.
- Issue 2: CalWORKs Outcomes and Accountability Review System (Cal-OAR) Conference Compromise: Approve resources to support the Cal-OAR process pursuant to adopted placeholder trailer bill language in both houses - \$600,000 in 2017-18, \$1.7 million in 2018-19, and \$2.4 million in 2019-10 and on-going (all General Fund).
- Issue 3: Online Client Assessment Tool (OCAT) Automation Integration Conference Compromise: Approve \$3.7 million in 2017-18, \$8.3 million in 2018-19, and \$3.8 million in 2019-20 and on-going (all General Fund) to enable the OCAT automation integration into the Statewide Automated Welfare System, with placeholder trailer bill language.

Issue 4: California Childrens' Services Medical Necessity Trailer Bill Costs Conference Compromise: Approve \$1.6 million General Fund costs to reflect the Legislature's rejection of the Administration's proposed trailer bill to clarify determinations of medically necessary services in educational settings.

#### **Department of Developmental Services**

Issue 5: Regional Centers Purchase-of-Services Conference Compromise: Within the regional center budget, reduce TANF reimbursement funding by \$17.5 million and increase General Fund by the same amount. This conforms to action taken in the Department of Social Services budget.

### Issue 8: Mental Health Crisis Beds - Approved as budgeted (Assembly 3-2) (Senate 5-0)

**Governor** proposed funding to construct a licensed 50-bed mental health crisis facility at California Institution for Men (CIM), located in Chino. The building will be designed to allow for operation at the intermediate care facility (ICF) level-of-care if treatment acuity needs fluctuate. This proposal requests \$3.7 million in funding for the preliminary plan phase of this project. The total estimated project cost is \$55,308,000.

**Minor Capital Outlay** 

### Issue 9: California State Prison, Los Angeles County - Fencing - Approved as budgeted (Assembly 3-2) (Senate 5-0)

**Governor** proposed funding to extend the height of the level I minimum support facility (MSF) perimeter fence at the California State Prison, Los Angeles County (LAC). This project will raise the height of the looped razor wire topping the fence an additional two feet, mitigating the existing safety and security concerns associated with the current fence design. The total estimated cost of this project is \$299,000 and would allow for the fence to be extended an additional two feet, and would ensure that the razor wire does not dip below eight feet off the ground.

Senate rejected the Governor's Proposal.

The Commission is a non-partisan organization that provides education-related research, data reporting, technical support, and opportunities for education policymakers from across the nation to convene and discuss issues.

### Issue 12: New Employee Orientation - Approved Trailer Bill Language (Assembly 3-2) (Senate 3-2)

**Governor** proposed trailer bill language to require public employers to provide exclusive representatives of public employees access to its new employee orientation, and the manner of the access is to be negotiated. Additionally, trailer bill language also specifies an arbitration process for disputes between the public employer and the exclusive representative, among other provisions.

Senate did not include trailer bill language regarding this issue.
