# Public Health Law & Policy

Tools like smoking restrictions, menu labeling, bans on trans-fats, and, now, efforts to reduce sodium content in processed food are ground-breaking public health achievements.

Public Health Law & Policy (PHLP) supports communities across the nation enacting such policies. Our multidisciplinary team pioneers new ways of using public policy and legal strategies. We offer practical solutions, consult on tough legal and policy problems, and train leaders to use our resources and model laws in their communities. We write model laws on ground-breaking strategies like smoke-free housing, and soda taxes with earmarks for public health prevention activities. We draft contracts to ensure schools and other public locations provide healthy foods and beverages, and to ensure school playgrounds are available for public use. We publish best practices in government contract law, public financing, land use and transportation, and economic development and redevelopment – all with a vision to promote and protect public health. We draft legal memos and fact sheets on enforcement of the law, the challenges of preemption, tort liability, and much more.
