## **Abandoned Vehicles, Parking, and Towing**

#### SB 518 Lowenthal

This bill creates incentives for local governments to implement parking reforms that reduce governmental or government-required subsidies for parking. This bill was amended to deal with a different subject matter.

#### SB 1024 **Oropeza**

This bill allows a court magistrate to order the impoundment of a tow truck operated in violation of city or county licensing requirements. Held in the Senate Transportation and Housing Committee without a hearing.

#### AB 519 Solorio

This bill requires towing companies to provide consumers with a Towing Fees and Access Notice and an itemized invoice of all towing and storage fees. The bill also specifies who is authorized to retrieve or inspect a towed vehicle and relives the towing company of responsibility for determining the authenticity of documents provided to demonstrate a person's authority. Signed into law. Chapter 566, Statutes of 2010.

### AB 1155 **Audra Strickland**

This bill makes additional traffic laws enforceable on off-street, private parking facilities upon enactment of an ordinance or resolution by a city or county. Vetoed.

### AB 1855 Yamada

This bill requires the Department of Motor Vehicles to advise an applicant for a disabled parking placard of the procedures to apply for a disabled or disabled veteran license plate and for the registration fee and vehicle license fee exemptions available to disabled veterans. Signed into law. Chapter 196, Statutes of 2010.

#### AB 1944 Fletcher

This bill requires the Department of Motor Vehicles, when evaluating an application for a disabled veteran license plate or placard, to accept a certificate from the United States Department of Veterans Administration certifying that the applicant is a disabled veteran in lieu of a certificate signed by a private doctor. Signed into law. Chapter 421, Statutes of 2010.

### AB 2067 **Bonnie Lowenthal**

This bill allows parking on the left side of the road on streets in Long Beach meeting specified criteria. Signed into law. Chapter 135, Statutes of 2010.

### AB 2228 Lieu

**Overnight parking in Venice Beach** This bill provides that the City of Los Angeles is not required to obtain a permit or approval from the Coastal Commission to establish an overnight parking restriction on public streets by nonresidents between the hours of 2 a.m. and 5 a.m. in the Venice coastal zone. This bill also authorizes the City of Los Angeles to establish a system of permits for purposes of exempting residents of the Venice coastal zone from the parking restrictions. Held in the Assembly Natural Resources Committee without a hearing.

#### AB 2567 Bradford Photographic enforcement of street sweeping parking violations

This bill authorizes local public agencies to use automated parking enforcement systems on street sweepers for street sweeping-related violations. Signed into law. Chapter 471, Statutes of 2010.

#### AB 2640 Arambula Tax exclusion for employer-subsidized parking

This bill repeals the personal income tax exclusion for employer-subsidized parking and establishes an allocated income tax credit for manufacturers' purchases of equipment and other property subject to the sales tax. Held on the Assembly Appropriations Committee suspense file.

#### AB 2710 Blumenfield

This bill authorizes a local authority, in lieu of posting signs that prohibit or restrict the stopping, parking, or standing of vehicles, to provide notice by issuing a warning citation advising the registered owner of the vehicle that he or she may be subject to a notice of violation for a subsequent violation and that a subsequent violation may result in the impounding of the vehicle. Held in the Assembly Transportation Committee without a hearing.

## Air Quality, Greenhouse Gas Emissions, and Fuels

### **SB 435** Pavlev

This bill prohibits a person from parking, using, or operating a motorcycle with a 2013 or newer model year that does not bear an exhaust system label certifying that the motorcycle meets the noise limits established by the United States Environmental Protection Agency. Signed into law. Chapter 407, Statutes of 2010.

## Air pollution: vehicle registration fees

This bill allows the South Coast Air Quality Management District and the Sacramento Metropolitan Air Quality management District to levy vehicle registration renewal fees of up to \$3 to fund emission control projects. This bill was amended to deal with a different subject matter.

#### SB 1114 Florez

## Emission reduction credits: private and public moneys

This bill authorizes an air quality management district or an air pollution control district to create an emission reduction credit from a marine vessel or locomotive emission reduction project that is funded by both public and private moneys. An emission reduction credit created pursuant to this provision is created only for the percentage of the emission reduction project that is paid for by private moneys. The bill provides that the state share of the credit would be 80 percent and requires the State Treasurer to sell the state's ownership share and deposit the proceeds into the Emission Reduction Credit Sales Fund, which this bill creates. *Held in the Senate Transportation and Housing Committee without a* hearing.

### SB 1156 Cedillo

## Heavy-duty trucks: grants: compliance

This bill appropriates \$20 million from the Enhanced Fleet Modernization Subaccount in the High Polluter Removal and Repair Account to the Air Resources Board to provide grants to owners of three or fewer heavy-duty diesel trucks that service the state's ports and railyards for the purchase of equipment that meets specified emission standards pursuant to drayage truck regulations. Held at the Assembly Desk.

This bill appropriates \$10 million from the Air Quality Improvement Fund for the purpose of

owners of on-road, heavy-duty diesel vehicles in order to purchase equipment for compliance with any regulation adopted by the Air Resources Board (ARB) for the reduction of air pollution from those vehicles. This bill also requires ARB to disregard cost-effectiveness when making grants for equipment eligible under the Carl Moyer Program from January 1, 2010 to January 1, 2011. Held in the Senate Transportation and Housing Committee without a hearing.

## Smog check: vehicle repair assistance and retirement programs

This bill (1) increases the income threshold to 225 percent of the federal poverty level that a person must meet in order to be deemed "low-income" and thus eligible for financial assistance for repairs required under the smog check program; (2) requires the Bureau of Automotive Repair (BAR) to provide \$1,500 to a low-income person and \$1,000 to any other person to retire his or her vehicle, rather than give BAR the discretion to provide an amount up to \$1,500, for both the Consumer Assistance Program administered as part of the smog check program and the Enhanced Fleet Modernization Program authorized by AB 118 (Núñez), Chapter 750, Statutes of 2007; and (3) deletes the provision of law that provides for repair assistance to vehicle owners whose vehicles have been directed to a test-only smog check station and directs the resulting savings to the vehicle retirement program. Signed into law. Chapter 231, Statutes of 2010.

## AB 1106 **Fuentes**

## Alternative and renewable fuel and vehicle technology

This bill authorizes the California Energy Commission to contract with small business financial development corporations to expend AB 118 Alternative and Renewable Fuels and Vehicle Technology Program funds. Signed into law. Chapter 356, Statutes of 2010.

## <u>SB</u> 1328 Lowenthal

This bill requires the Air Resources Board to consider specified matters if adopting or amending regulations to reduce motor vehicle cabin temperature in order to reduce greenhouse gas emissions. Signed into law. Chapter 648, Statutes of 2010.

## <u>SB 1340</u> Kehoe

This bill expands the use of the voluntary contractual assessment to finance electric vehicle charging infrastructure affixed on real property and expands the Property Assessed Clean Energy Reserve program to assist local jurisdictions in financing the installation of electric vehicle charging infrastructure. This bill also makes the costs of homeowners' electrical work needed to fuel electric vehicles eligible for subsidies under the California Energy Commission's Alternative and Renewable Fuel and Vehicle Technology Program. Signed into law. Chapter 649, Statutes of 2010.

#### AB 1740 Jeffries

This bill increases the number of specially constructed vehicles, from 500 to 750, that the Department of Motor Vehicles may register using a process that may exempt the vehicle from the smog check program and clarifies that an owner of a specially constructed vehicle may re-register his or her vehicle with a different model year in order to take advantage of the exemption. Failed passage in the Senate Transportation and Housing Committee.

#### **AB 2289** Eng

This bill makes several changes to the smog check program, including requiring that vehicles be inspected using the vehicle's onboard diagnostic equipment and establishing performance standards that test-only and Gold Shield stations must meet in order to be eligible to issue certificates of compliance or noncompliance to high-emitting vehicles directed to them. This bill also makes several changes to the Bureau of Automotive Repair's (BAR) process for enforcement of smog stations, authorizes BAR to revise its standards for certifying and decertifying test equipment, allows BAR, rather than smog check stations, to enter into a contract for the supply or service of testing equipment or software, and requires BAR to submit an annual report to the Legislature on the effects of using onboard diagnostic testing. Signed into law. Chapter 258, Statutes of 2010.

### Mendoza AB 2311

This bill requires the executive officer of the Air Resources Board to conduct three reviews of the Low Carbon Fuel Standard regulation. Held on the Assembly Appropriations Committee suspense file.

### AB 2461 Emmerson

This bill resets the period of time in which vehicle owners who incorrectly or fraudulently registered their vehicles may apply to the Department of Motor Vehicles for amnesty. The new period is July 1, 2011 until June 30, 2012. The bill also provides that specially constructed vehicles seeking amnesty are exempt from the visual component of the smog inspection. Signed into law. Chapter 388, Statutes of 2010.

## **Air Transportation**

### SB 1141 **Negrete McLeod**

This bill (1) makes various changes to the general statutory requirement that each county form an airport land use commission (ALUC), (2) authorizes the Division of Aeronautics at the Department of Transportation to establish a fund to provide grants to counties for the establishment of an ALUC, and (3) prohibits airports in counties that have not established an ALUC from receiving state Aeronautics Account funds if an ALUC has not been established in that county. Vetoed.

### **SB 1264** Leno

This bill requires a commercial airline to provide passengers adequate food and refreshment, waste removal service, electrical service, fresh air, and light when there are tarmac delays of more than two hours. The bill also requires an airline to provide conspicuous notice regarding passenger rights and complaint information and authorizes the Public Utilities Commission to levy a civil penalty of up to \$27,500 per passenger for violations of these provisions if the federal government discontinues levying fines on air carriers for violations of federal regulations. Failed passage on the Senate Floor.

This bill expands the definition of emergency aircraft flights for medical purposes to include nonemergency flights to return aircraft or equipment used during a medical emergency, or emergency personnel and first responders involved in treating the medical emergency, back to the base of operation. Signed into law. Chapter 54, Statutes of 2010.

### **AJR 41** Lieu

This resolution memorializes the Federal Aviation Administration, the United States Environmental Protection Agency, the United States Department of Transportation, and the members of the California congressional delegation to work collaboratively to review noise and air pollution emission levels and the safety of flight operations at Santa Monica Municipal Airport. Resolution Chapter 115, Statutes of 2010.

## **Building Standards**

### **SB 7** Romero

The bill establishes the maximum exit access travel distance for large warehouses to be 400 feet, as opposed to the California Building Code's current 250 feet, and maintains this 400-foot standard in statute until it is adopted by the Building Standards Commission as part of the California Building Code. Held in the Assembly Rules Committee.

### SB 518 Lowenthal

This bill requires the Building Standards Commission as part of the next triennial edition of the California Building Standards Code to adopt standards for the construction, installation, or alteration of graywater systems for indoor and outdoor uses in non-residential occupancies. Signed into law. Chapter 622, Statutes of 2010.

## SB 918 Pavlev

This bill requires the Department of Public Health to establish standards for various types of water recycling and to investigate and report on the feasibility of developing uniform water recycling criteria for direct potable reuse by December 31, 2016. Signed into law. Chapter 700, Statutes of 2010.

## AB 1693 Ma

This bill requires the California Building Standards Commission to consider building standards proposed by state agencies at 18-month intervals, as opposed to annual intervals. *Signed into law*. Chapter 145, Statutes of 2010.

## AB 1975 Fong

This bill requires the Department of Housing and Community Development to adopt building standards requiring the installation of individual water meters or submeters in newly constructed multiunit residential buildings. It also requires the Department to convene a stakeholder group to make recommendations regarding procedures for billing occupants of rental housing units for water use by building owners. The bill requires water suppliers to determine whether the installation of individual

water meters or submeters is required for new connections to multi-unit residential buildings. Held on the Senate Appropriations Committee suspense file.

### AB 2001 Harkev

This bill transfers the responsibilities of the Department of Public Health to adopt building standards to

AB 2472 Huffman

This bill authorizes Marin County and an unspecified local jurisdiction to adopt a pilot program for green innovation building permits to promote and facilitate innovation and research regarding environmentally sustainable building materials, methods, and designs not yet considered or addressed in the California Building Standards Code. Held in the Assembly Business, Professions, and Consumer Protection Committee after a hearing.

#### AB 2516 Hill

This bill requires the Department of Housing and Community Development to establish an Accessible Housing Task Force to expand the amount of housing near public transit that is accessible and habitable by people of all ages and disabilities. Held on the Assembly Appropriations Committee suspense file.

#### AB 2701 Eng

This bill places qualified playgrounds and playground sites that have historical or cultural significance under the exclusive jurisdiction of the State Historical Building Code. Vetoed.

## **Common Interest Developments**

### SB 995 Strickland

This bill provides that a stock cooperative or community apartment project for senior citizens that was established before enactment of the Davis-Stirling Common Interest Development Act and is converting to a condominium shall not be required to file a condominium plan as part of the documents required to be submitted to the Department of Real Estate. Held in the Senate Local Government *Committee without a hearing.* 

#### SB 1128 DeSaulnier

This bill allows a non-profit entity that provides services to a common interest development under a declaration of trust, if it received transfer fees prior to January 1, 2004, to continue to charge transfer fees to the purchasers of units within the common interested development to which it provides services. The bill also clarifies that such entities are subject to the open records provisions of the Davis-Stirling Act. Signed into law. Chapter 322, Statutes of 2010.

### AB 1726 Swanson

This bill allows for a reduction in the quorum requirement needed to approve an election of directors in a common interest development, subject to referendum by the members of a CID. The bill also clarifies that executive sessions are part of a meeting and allows board members to participate in a meeting through use of a conference telephone or electronic video screen communication. Vetoed.

### AB 1793 Saldaña

This bill prohibits a common interest development from enforcing any provision of its governing documents that prohibits or has the effect of prohibiting the use of artificial turf or any other synthetic surface that resembles grass. Vetoed.

## Pilot program for green innovation building permits

#### AB 1927 Knight

This bill requires, after January 1, 2011, the membership of a common interest development to vote on changes to the governing documents that prohibit the rental or lease of a separate interest in a CID. Vetoed.

#### AB 2016 Torres

This bill provides that a homeowner association's recorded request for notices of default does not constitute a document that either effects or evidences a transfer or encumbrance of an interest in real property or that releases or terminates any interest, right, or encumbrance of an interest in real property. Signed into law. Chapter 133, Statutes of 2010.

#### **Brownley** AB 2502

This bill makes a number of changes to the law governing the collection of delinquent assessments in a common interest development, including (1) prohibiting a homeowner from waiving his or her right to have payments applied first towards the delinquent assessment; (2) clarifying that the requirement to apply payments first towards a delinquent assessment also applies to an agent of the association; and (3) prohibiting an association or its agent from accepting partial payments made in accordance with a payment plan. Held in the Assembly Judiciary Committee without a hearing.

## **Driver Licensing**

## SB 1162 Walters

This bill eliminates the \$50 fee that a traffic violator school owner must pay to the Department of Motor Vehicles to renew the license for each of its classroom locations. Held in the Senate Transportation and Housing Committee without a hearing.

#### **SB 1394** Kehoe

This bill removes the sunset dates on the laws that require the Department of Motor Vehicles (DMV) to (1) check the record of an applicant before issuing or renewing a driver's license for any reports from a traffic officer, family member, or physician of evidence that the applicant may not be able to operate a motor vehicle safely, and (2) reexamine a driver upon report from a family member that he or she may not be able to operate a motor vehicle safely. The bill also extends by one year the sunset date on the law requiring DMV to reexamine a driver when DMV receives a report from a health officer that the person has a disorder characterized by a lapse of consciousness. On Senate Concurrence.

### SB 1395 Alquist

This bill requires, on and after July 1, 2011, that the Department of Motor Vehicles (DMV) inquire verbally of a person in a DMV office applying for or renewing a California driver's license or identification card whether or not he/she will be an organ donor. The bill also authorizes creation of a living donor registry to sign up kidney donors. Signed into law. Chapter number 217, Statutes of 2010.

## AB 1502 Eng

<u>Instructional permits:</u> <u>supervision by out-of-state military</u>

This bill authorizes a non-California resident parent, spouse, or guardian on active United States military service in California to supervise the required 50 hours of driving practice for a minor driving with an instruction permit, to accompany a minor driving with a provisional driver's license, and to accept civil liability for a minor applying for a driver's license. *This bill was amended to deal with a different subject matter*.

## AB 1648 Jeffries

## **Driver's licenses: firefighting equipment**

This bill changes the type of driver's license required to operate firefighting equipment from a class A or B commercial driver's license or a restricted firefighting license to a class C license with a firefighter endorsement provided certain requirements are met, including that the firefighter has undergone driver training that meets specified criteria and has completed a medical exam within four years of applying for or renewing the license. *Signed into law. Chapter 360, Statutes of 2010.* 

## AB 1952 Niello

This bill requires persons under the age of 21 to complete a motorcyclist training course prior to obtaining an instruction permit to operate a two-wheel motorcycle, motor-driven cycle, motorized scooter, motorized bicycle, moped, or bicycle with an attached motor and requires the permittee to hold the instruction permit for a minimum of six months prior to obtaining a motorcycle license. *Signed into law. Chapter 586, Statutes of 2010.* 

## AB 2097 Miller

This bill establishes a process whereby a person who has requested that the Department of Motor Vehicles (DMV) hold his or her home address confidential shall provide to DMV his or her employment address for the purpose of processing the service and collection of traffic, parking, and toll road violations. *Held on the Senate Appropriations Committee suspense file*.

## AB 2099 Miller

This bill requires the California Driver's Handbook, when next revised or reprinted by the Department of Motor Vehicles, to refer drivers to the website for JourneySafe.org. *Held on the Assembly Appropriations Committee suspense file*.

## AB 2144 Gilmore

This bill amends various provisions of state law to conform with the requirements of new federal law governing commercial vehicle drivers. *Signed into law. Chapter 216, Statutes of 2010.* 

## AB 2464 Huffman

This bill requires that drivers under the age of 18 complete driver education and training prior to obtaining an instruction permit, raises the minimum age, from 18 to 21, of a person that may accompany a permittee who is 18 years of age or older, requires that the instruction permit state explicitly that a permittee must complete 50 hours of supervised driving practice, and requires the instructor of a driving school to provide a driving log for students to use to document their driving practice. *Vetoed.*

### AB 2499 **Portantino**

This bill consolidates the licensing of all traffic violator schools under the authority of the Department of Motor Vehicles and treats a violation as a conviction, rather than as a dismissal, if the person attends a traffic violator school. Signed into law. Chapter 599, Statutes of 2010.

## **Housing Programs and Finance**

### SB 194 Florez

This bill requires entitlement jurisdictions under the federal Community Development Block Grant Program to prioritize the needs of disadvantaged unincorporated communities in allocating technical assistance funds if there is no local government board that represents the disadvantaged community. Vetoed.

### SB 454 Lowenthal

This bill deletes the sunset date on three sections of law that require the owners of affordable housing to provide notice to tenants and governmental entities before converting a property to market-rate apartments and that give a limited priority to preservation purchasers in the event the owner wishes to sell. Signed into law. Chapter 308, Statutes of 2010.

### SB 958 Lowenthal

This bill dedicates funds that California receives from the National Housing Trust Fund to the Department of Housing and Community Development's Multifamily Housing Program, except that the Legislature may appropriate up to 10% of the funds to the CalHome Program. On the Assembly Floor.

## SB 996 Lowenthal

This bill clarifies that the Long Beach Affordable Housing Coalition is entitled to a refund of the property taxes paid on its behalf for the Century Freeway properties. Held on the Senate Appropriations Committee suspense file.

### SB 1216 Cedillo

This bill authorizes the California Tax Credit Allocation Committee to exchange state low-income housing tax credits for federal low-income housing tax credits within a project. Held on the Senate Appropriations Committee suspense file.

### Duchenv SB 1250

This bill expands the possessory interest exemption currently provided to private operators of family housing on military bases to include non-family housing. Signed into law. Chapter 327, Statutes of 2010.

### SB 1287 Duchenv

This bill appropriates \$900,000 from the Disaster Relief Fund to the Department of Housing and Community Development for housing low- and moderate-income persons who have been impacted by the April 4, 2010 earthquake in Baja California, Mexico. Held on the Senate Appropriations *Committee suspense file.*

This bill requires the Department of Housing and Community Development to include in its annual report for each Proposition 1C program the amount of funds it awarded and encumbered in the prior year. This bill was amended to deal with a different subject matter.

## SBX8 27 Lowenthal

This bill dedicates funds that California receives from the National Housing Trust Fund to the Department of Housing and Community Development's Multifamily Housing Program, except that the Legislature may appropriate up to 10% of the funds to the CalHome Program. Held at the Assembly desk.

### SBX8 28 Yee

Internet service accessibility in affordable housing This resolution encourages state and local multifamily housing lending agencies to align their policies on the provision of free internet access with those of the Tax Credit Allocation Committee. Held at the Assembly desk.

### AB 183 Caballero

This bill provides a tax credit of up to \$10,000 for the purchase of a new home or the purchase of any home by a first-time homebuyer. The bill limits the amount of the aggregate credit for first-time homebuyers to \$100 million and for new homes to \$100 million, for a total of \$200 million in allocated credits. Signed into law. Chapter 12, Statutes of 2010.

## Joe Serna, Jr. Farmworker Housing Grant Program: definition of agricultural employees

This bill expands the definition of who may reside in farmworker housing for the purpose of the Joe Serna, Jr. Farmworker Housing Grant Program to include any person who works on or off the farm in processing of any agricultural commodity until it is shipped for distribution. Signed into law. Chapter 348, Statutes of 2010.

#### AB 2014 Torrico

## Tax credits for home energy efficiency improvements

This bill establishes a pilot program for the counties of Alameda, Contra Costa, San Mateo, and Santa Clara, whereby homeowners can claim a credit against their income taxes for energy efficiency improvements on their principal residence. Held on the Assembly Appropriations Committee suspense file.

### AB 2033 Torres

This bill requires the Department of Housing and Community Development to establish a balance of state continuum of care (COC) and apply for federal McKinney-Vento Homeless Assistance Act funds by September 1, 2011 and to notify the Legislature's housing committees of its efforts to establish a state COC by September 30, 2011. The bill also allows counties that have established COC programs to join the state COC rather than administering their own program. Held on the Senate Appropriations Committee suspense file.

#### AB 2064 John Pérez

This bill requires the Department of Housing and Community Development, no later than 30 days after the effective date of the bill, to issue a notice of funding availability for the full balance of funds available to the Emergency Housing Assistance Program. This bill was amended to deal with a different subject matter.

### AB 2085 Saldaña

This bill requires the Bureau of State Audits to conduct periodic audits of all Proposition 1C programs, including the Infill Infrastructure Grant Program and the Transit Oriented Development Program, and authorizes the use of bond funds for this purpose. *Held in the Assembly Housing and Committee* Development Committee without a hearing. This provision is also included in AB 2762 (Assembly Housing and Community Development Committee).

### AB 2087 Torres

This bill expands the definition of a home for purposes of the CalVet Home Loan Program to include a residence of two to four units that meets specified requirements. Signed into law. Chapter 542, Statutes of 2010.

This bill provides that if a property contains five or more dwelling units and a public entity is part of a recorded deed restriction or is a party to a recorded rent regulatory agreement on the property, the public entity may, by written notice to the trustee, postpone the sale date by no more than 60 days. Signed into law. Chapter 597, Statutes of 2010.

#### AB 2508 Caballero **Infill Incentive Grant Program density requirements**

This bill allows a city of greater than 100,000 in population in a metropolitan statistical area of less than two million to petition the Department of Housing and Community Development for an exception to the density requirements of the Infill Infrastructure Grant Program if the city believes that it is unable to meet those requirements. Signed into law. Chapter 390, Statutes of 2010.

#### AB 2536 Carter

**Propositions 46 and 1C: supportive housing** This bill allows Emergency Housing and Assistance Program funds from Propositions 46 and 1C to be used for supportive housing projects. Vetoed.

#### AB 2651 Knight

This bill establishes the Veterans' Bond Payment Fund (VBPF) and provides that CalVet bonds shall be repaid from the VBPF first and only from the General Fund if there are insufficient funds within the VBPF. Signed into law. Chapter 27, Statutes of 2010.

#### AB 2709 Blumenfield **California Housing Finance Agency: federal loan guarantees**

This bill authorizes the California Housing Finance Agency to issue loan guarantees backed by the United States Department of Housing and Urban Development. Held in the Assembly Housing and Community Development Committee without a hearing.

This bill (1) amends the Fair Employment and Housing Act's civil penalty caps to conform with those imposed in violation of the federal Fair Housing Amendments Act, (2) makes technical revisions to consistently include "source of income" as a characteristic which is protected from housing discrimination, and (3) clarifies that admission preferences based on age, imposed in connection with a federally-approved housing program, do not constitute age discrimination in housing. Signed into law. Chapter 524, Statutes of 2010.

#### Knight **AB 1607**

This bill allows a housing authority to require any application or document filed with the public housing authority to be signed and submitted under penalty of perjury. Failed passage in the Assembly Public Safety Committee.

#### AB 1838 **Bill Berryhill**

This bill, until January 1, 2012, adds the district attorney in San Joaquin County to two existing pilot projects that permit city attorneys or prosecutors to bring an unlawful detainer action against a tenant for unlawful activities regarding firearms, ammunition, and controlled substances. Vetoed.

#### AB 2706 Lowenthal

This bill adds homeless persons to the list of individuals protected from violence and intimidation under the Ralph Civil Rights Act. Vetoed.

Signed into law. Chapter 367, Statutes of 2010.

## AB 2425 Hagman

**Regional housing need allocation and La Habra Heights** This bill exempts the City of La Habra Heights from receiving an allocation of the regional housing need during its next housing element planning period. Failed passage in the Assembly Housing and Community Development Committee.

### <u>AB</u> 1964 Torres

### AB 2029 Cook

This bill exempts manufactured-home or mobilehome households whose income is below the federal poverty level from paying annual registration fees. Failed passage in the Assembly Housing and Committee Development Committee.

### AB 2120 Silva

This bill requires the management in a mobilehome park to either provide all homeowners with a copy of the Mobilehome Residency Law (MRL) annually or provide written notice that there has been a change to the MRL and that homeowners may obtain a copy of the text of the law from management at no charge. Signed into law. Chapter 90, Statutes of 2010.

## AB 2439 Nestande

This bill authorizes the management of a mobilehome park to permit a mobilehome homeowner, without regard to whether there is a medical emergency or need for medical treatment, to sublet his or her mobilehome or space in accordance with the reasonable rules and regulations of the park and exempt from a local rent control ordinance. Signed into law. Chapter 493, Statutes of 2010.

### SB 1371 Correa

This bill authorizes the California Transportation Commission to issue a letter of no prejudice for a project funded by a specified portion of the Safe, Reliable High-Speed Passenger Train Bond Act for the 21<sup>st</sup> Century (Prop 1A), provided certain conditions are met. Signed into law. Chapter 292, Statutes of 2010.

### AB 289 Galgiani

This bill provides guidance to the California High-Speed Rail Authority (HSRA) over the expenditures of \$2.25 billion in federal American Recovery and Reinvestment Act grant funds, authorizes the Governor to appoint additional executive staff for the HSRA, and establishes intent language to create an Office for Project Controls and Risk Management. Vetoed.

This bill increases the base fine for using a hand-held cell phone for talking or texting while driving a motor vehicle, from \$20 to \$50 for an initial violation and from \$50 to \$100 for a subsequent violation; prohibits the use of a hand-held phone for talking or texting while riding a bicycle, establishes a total fine of \$20 for a violation, requires the Department of Motor Vehicles to include the dangers of distracted driving in its examination for a driver's license, and requires \$10 of each fine collected for talking or texting while operating a motor vehicle or bicycle to be deposited in the Driver Distraction Education Fund, which this bill creates, for an education program on the dangers of talking or texting while driving. Held on the Assembly Appropriations Committee suspense file.

#### **AB 458** Cook

This bill exempts a vehicle operated by a peace officer and owned or leased by the peace officer's employer from California law prohibiting or limiting window tinting or glazing. *Held in the Senate* Transportation and Housing Committee without a hearing.

### **AB 909** Hill

This bill reduces the fine for violations involving a right turn, or a left turn from a one-way street onto another one-way street, against a red light. Vetoed.

#### AB 1845 Gilmore

This bill authorizes a local authority, by ordinance or resolution, to permit a senior citizen to operate a golf cart on streets and highways under its jurisdiction that are designated under an ordinance or resolution. *Held in the Assembly Transportation and Housing Committee without a hearing.* 

### Bradford AB 2572

## Ashburn **SB 921**

This bill authorizes the California Transportation Commission to relinquish to the City of Bakersfield or the County of Kern the portion of State Highway Route 58 that is located within the jurisdiction of the city or county. *Held in the Senate Transportation and Housing Committee without a hearing.* These provisions were enacted as part of SB 1318 (Transportation and Housing Committee).

## **SB 993** Huff

State Highway Route 66 relinquishment This bill authorizes the California Transportation Commission to relinquish a specified portion of State Highway Route 66 to the City of Claremont. Signed into law. Chapter 499, Statutes of 2010.

## SB 1245 Simitian

This bill prohibits the charging of tolls on high-occupancy vehicles (HOVs) that meet the applicable occupancy level for use of an HOV or high-occupancy toll (HOT) lane, excluding toll bridges. ### AB 2147 V. Manuel Pérez

This bill modifies the state Safe Routes to School (SR2S) program by adding "benefit to a low-income school" as a factor that the Department of Transportation (Caltrans) shall use to evaluate grant proposals, by authorizing school districts to apply for SR2S grants, by refining the factor relating to the public participation process that local agencies are encouraged to undertake, and by requiring Caltrans to establish an advisory body that includes a representative from a low-income community. Vetoed.

#### AB 2520 Solorio

This bill authorizes the California Transportation Commission to issue a letter of no prejudice for a project funded by the Clean Air and Transportation Improvement Act of 1990, provided certain conditions are met. *Held in the Assembly Transportation Committee without a hearing.*

This bill changes the overhead rate that the Department of Transportation charges for reimbursed work it performs for local agencies or private entities. Held in the Senate Appropriations Committee without a hearing.

## <u>AB</u> 2703 John A. Pérez

This bill authorizes the California Transportation Commission to issue a letter of no prejudice for a project funded by a specified portion of the Safe, Reliable High-Speed Passenger Train Bond Act for the 21<sup>st</sup> Century (Proposition 1A), provided certain conditions are met. *Re-referred to the Senate Rules* Committee.

## AB 2704 Gaines

This bill requires the continuance of funding for local street and road snow removal in the event state gas tax subvention to cities and counties are diverted for other purposes. Signed into law. Chapter 101, Statutes of 2010.

## **Bonnie Lowenthal** AB 2755

This bill requires the Los Angeles County Metropolitan Transportation Authority (Metro) to let a contract to the lowest responsible bidder when the purchase price of the construction of all facilities exceeds \$100,000, rather than \$25,000. This bill also authorizes Metro to award individual contracts, not exceeding \$8,000,000 per year, providing for the issuance of job orders for construction work with compensation for the work based on unit prices and defines "job 98 order" and "unit price" for these purposes. The bill also authorizes a Metro contractor to enter into subcontracts with subcontractors that are not listed in the bid for the job order contract. Held in the Assembly Transportation Committee without a hearing.

## **Budget Committee** ABX86

This bill eliminates, effective July 1 2010, the sales tax on gasoline and replaces it with an gasoline excise tax designed to generate an equivalent amount of revenue. This bill also provides for a revenue-

This bill changes provisions governing transportation and public transit funding to implement the gas tax swap. Signed into law. Chapter 12, Statutes of 2009-10.

## Vehicle Registration, Vehicle Dealers, and Vehicles

## **SB 88** DeSaulnier

This bill increases the fees charged to acquire firefighter license plates and authorizes these plates to be used as family heirlooms. Signed into law. Chapter 304, Statutes of 2010.

## **SB 632** Lowenthal

This bill allows the South Coast Air Quality Management District and the Sacramento Metropolitan Air Quality management District to levy vehicle registration renewal fees of up to \$3 to fund emission control projects. This bill was amended to deal with a different subject matter.

### **SB 1004** Huff

# Licensed dealers and salespersons: credit scores

This bill allows a vehicle salesperson to work for multiple dealerships with a common controlling interest, makes changes to posting requirements for salesperson and dealer licenses, and requires dealers to provide a credit score disclosure that informs the consumer of each credit score obtained and used. Signed into law. Chaptered 483, Statutes of 2010.

### **SB 1208** Strickland

This bill permits the Director of the Department of Motor Vehicles to establish a biennial vehicle registration option and to reassign a vehicle to the biennial registration period upon the request of a vehicle owner, who would then be entitled to a 5% reduction in basic registration fees. Held in the Senate Transportation and Housing Committee without a hearing.

### SB 1220 Wolk

Vehicles: emergency vehicles: fire apparatus This bill expands the list of vehicles exempt from size and weight limits in state law to include vehicles that are used to transport personnel and equipment under emergency conditions, to support the suppression of fires, or to mitigate other hazardous situations. Signed into law. Chaptered 487, Statutes of 2010.

### SB 1229 Denham

This bill adds all-terrain vehicles to the list of vehicles that state law classifies as implements of husbandry and which may therefore be driven incidentally on public roads. Signed into law. Chapter 110, Statutes of 2010.

## SB 1295 Dutton

This bill allows the family of a deceased recipient of the Purple Heart or Legion of Valor medal to keep one of the special license plates as an heirloom, if there is no surviving spouse or upon death of the surviving spouse. Signed into law. Chapter 283, Statutes of 2010.

#### SB 1445 DeSaulnier

This bill increases by one dollar the fee to register a vehicle to pay for regional land use planning activities. This bill also makes changes to the membership and duties of the Office of Planning and Research's Planning Advisory and Assistance Council. Re-referred from floor to the Assembly Appropriations Committee.

### SB 1453 Price

This bill permits the Department of Motor Vehicles to investigate and develop a plan for the use of digital electronic license plates in California, which would allow the plates to function both as license plates and venues for advertising or other messages. *Held on the Senate Appropriations Committee* suspense file.

This bill expands the use of the voluntary contractual assessment to finance electric vehicle charging infrastructure affixed on real property and expands the Property Assessed Clean Energy Reserve program to assist local jurisdictions in financing the installation of electric vehicle charging infrastructure. This bill also makes the costs of homeowners' electrical work needed to fuel electric vehicles eligible for subsidies under the California Energy Commission's Alternative and Renewable Fuel and Vehicle Technology Program. Signed into law. Chapter 649, Statutes of 2010.

## SB 1348 Steinberg

This bill exempts a vehicle operated by a peace officer and owned or leased by the peace officer's employer from state law prohibiting or limiting window tinting or glazing. Held in the Senate Transportation and Housing Committee without a hearing.

### AB 498 Havashi

This bill requires the development of a special license plate for former prisoners of war (POWs) that does not identify the status of the plate holders as former POWs. Signed into law. Chapter 345, Statutes of 2010.

### AB 584 Huber

This bill allows, until January 1, 2016, the County of Amador and the cities of Jackson, Sutter Creek and Amador to establish a neighborhood electric vehicle transportation plan. Signed into law. Chaptered 437, Statutes of 2010.

### AB 1097 Eng

This bill requires license plates to be mounted parallel to the ground so that the characters are upright. Held in the Senate Transportation and Housing Committee without a hearing. These provisions were enacted in SB 1318 (Transportation and Housing Committee).

### Jeffries AB 1740

This bill increases the number of specially constructed vehicles, from 500 to 750, that the Department of Motor Vehicles may register using a process that may exempt the vehicle from the smog check program and clarifies that an owner of a specially constructed vehicle may re-register his or her vehicle with a different model year in order to take advantage of the exemption. Failed passage in the Senate Transportation and Housing Committee.

#### AB 1772 Mendoza Vehicles: group axle weight exemption: idle reduction technology

This bill allows trucks equipped with idle reduction technology to exceed the group axle weight limit by up to 400 pounds or the actual weight of the idle reduction technology, whichever is less. Held on the Senate Appropriations Committee suspense file.

## AB 1781 Villines

This bill authorizes, until January 1, 2016, the City of Fresno to establish a neighborhood electric vehicle transportation plan. Signed into law. Chaptered 452, Statutes of 2010.

## AB 1815 Emmerson

This bill allows the issuance of license plates displaying themes of professional stock car racing or professional stock car racing drivers. Held in the Senate Transportation and Housing Committee without a hearing.

## AB 1845 Gilmore

This bill authorizes a local authority to permit a senior citizen to operate a golf cart on streets and highways under its jurisdiction that are designated under an ordinance or resolution. Held in the Assembly Transportation Committee without a hearing.

# **Neighborhood electric vehicles**

This bill requires the Department of Motor Vehicles to advise an applicant for a disabled parking placard of the procedures to apply for a disabled or disabled veteran license plate and for the registration fee and vehicle license fee exemptions available to disabled veterans. Signed into law. Chapter 196, Statutes of 2010.

#### AB 1908 Cook

This bill allows the Department of Veterans Affairs to redesign the veterans' organizations license plates. Signed into law. Chapter 166, Statutes of 2010.

### AB 1942 Fletcher

This bill authorizes the placement of video event recorders in specified locations on the windshield of a vehicle. Signed into law. Chaptered 458, Statutes of 2010.

## AB 1944 Fletcher

This bill requires the Department of Motor Vehicles, when evaluating an applications for a disabled veteran license plate or placard, to accept a certificate from the United States Department of Veterans Administration certifying that the applicant is a disabled veteran in lieu of a certificate signed by a private doctor. Signed into law. Chapter 421, Statutes of 2010.

#### AB 2097 **Department of motor vehicles: confidential home addresses: citations** Miller

This bill establishes a process whereby a person who requests that the Department of Motor Vehicles (DMV) hold his or her home address confidential shall provide to DMV his or her employment address for the purpose of processing the service and collection of traffic, parking, and toll road violations. Held on the Senate Appropriations Committee suspense file.

### AB 2245 Hill

This bill prohibits a vehicle from being equipped with an aftermarket horn that emits a sound greater than 110 decibels. *Vetoed*.

## AB 2294 **Block**

This bill defines the term "pedicab" and authorizes a local entity to license and regulate the operation of pedicabs for hire, including requiring a pedicab operator to obtain a valid California driver's license. Signed into law. Chapter 614, Statutes of 2010.

## AB 2303 Tran

This bill requires the Department of Motor Vehicles to implement a program allowing certain registrants to pay their vehicle registration fees by installment. *Failed passage in the Assembly* Transportation Committee.

## AB 2461 Emmerson

This bill resets the period of time in which vehicle owners who incorrectly or fraudulently registered their vehicles may apply to the Department of Motor Vehicles for amnesty. The new period is July 1, 2011 until June 30, 2012. The bill also provides that specially constructed vehicles seeking amnesty are exempt from the visual component of the smog inspection. Signed into law. Chapter 388, Statutes of 2010.

## AB 2644 Fuller

This bill excludes from the definition of a commercial vehicle any pickup truck that is not used for the transportation of property for hire, compensation, or profit. It also exempts pickup trucks from commercial weight fees. *Held in the Assembly Transportation Committee without a hearing*.

## AB 2646 John A. Pérez

## Vehicles registration: required information

This bill requires that the application for an original or renewal vehicle registration, and the registration card itself, include the residence address of the vehicle's owner, unless the owner is a business, in which case the business address is required on the application and registration card. *Held on the Assembly Appropriations Committee suspense file.*
