Subject: Education: at-promise youth.

NOTE: This bill has been referred to the Committees on Education and Public Safety. A "do pass" motion should include referral to the Committee on Public Safety.

SUMMARY

This bill changes the term "at-risk" to "at-promise" in various sections of the Education Code and Penal Code.

BACKGROUND

Existing law references at-risk students in various sections of the Education Code and Penal Code, including but not limited to:

- Defines "at-risk" student as a student enrolled in high school who is at risk of dropping out of school, as indicated by specified criteria. (Education Code § 54690)
- 2) Defines "at-risk" youth as individuals from age 5 to 20 years of age and who fall into one or more specified categories. (Penal Code § 13825.4)

ANALYSIS

This bill changes the term "at-risk" to "at-promise" in various sections of the Education Code and Penal Code, relative to:

- 1) The requirement that the California Department of Education (CDE) monitor adherence to statute and regulations regarding educational equity. (EC § 234.1)
- 2) Reimbursement rates for child care and development programs. (EC § 8266.1)
- 3) The selection of grantees to participate in the 21st Century High School After School Safety and Enrichment for Teens program. (EC § 8423)
- 4) The Health Start Support Services for Children Act. (EC § 8801)
- 5) Middle college high schools. (EC § 11300)
- 6) The California Youth Leadership Project. (EC § 33426)

- 7) Foster Youth Services. (EC § 42920)
- 8) A field experience program as part of a program of professional preparation for a teaching or services credential. (EC § 44324)
- 9) Professional development training for classified school employees. (EC § 45391)
- 10) Community day schools. (EC § 48660.1)
- 11) Model gang violence suppression and substance abuse prevention curriculum. (EC § 51266)
- 12) Partnership academies. (EC § 54690)
- 13) California Longitudinal Pupil Achievement Data System. (EC § 60901)
- 14) Golden State Scholarshare College Savings Trust. (EC § 69981)
- 15) The Robert Presley Institute of Corrections Research and Training. (PC § 5087)
- 16) Board of State and Community Corrections. (PC § 6025 and § 6027)
- 17) California Gang, Crime, and Violence Prevention Partnership Program. (PC § 13825.2, § 13825.4, and § 13825.5)
- 18) Gang Violence Suppression Program. (PC § 13826.11)
- 19) Comprehensive Alcohol and Drug Prevention Education component of the Suppression of Drug Abuse in Schools Program. (PC § 13864)
- 20) Provides that "at-promise" has the same meaning as "at-risk."
- 21) Deletes obsolete references and makes other technical changes.

STAFF COMMENTS

- 1) **Need for the bill.** According to the author, "Perception plays an important role in the success or failure of students. As a result of the stigma created through the use of 'at-risk,' these students are subjected to an expectation to fail and can be treated as such. Transitioning from 'at-risk youth' to 'at-promise youth' is an important step in eliminating the biased mindset that is too pervasive in schools and communities across the country."
- 2) **Double-referred.** This bill has been double-referred to the Senate Public Safety Committee, as this bill also amends the Penal Code.
- 3) **Prior legislation.** ACR 197 (Jones-Sawyer, Chapter 106, 2018) encourages the people of the State of California to recognize the potential and possibilities of our children, instead of focusing on their deficits.
